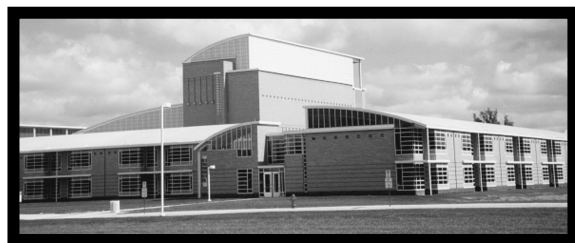

PERRY ALUMNI ATHLETIC HALL OF FAME NOMINATION FORM

CRITERIA

- Nominees must have graduated at least ten years prior to the selection date. Individuals may be nominated posthumously.
- Nominations may be submitted by any Perry High School graduate, Perry community member or member of the Selection Committee.

There are four (4) categories of nominees eligible:

1. **Athlete** – an athlete's class must have graduated at least ten (10) years prior to selection.
2. **Coach/Administrator** – a coach or administrator must have served on the Perry Schools staff for at least ten (10) years and must have retired or left the school system prior to selection.
3. **Team** – A team must have placed in top four (4) positions at state event for their sport.
4. **Honorary** – An alumnus or non-alumnus Perry resident may also be chosen for making a significant impact on the Perry Schools athletic program.

One or more of the following criteria should be of exceptional quality to justify a nominee's selection. Those nominated in the athlete category **must meet several** of the listed criteria to be chosen for selection.

1. Varsity level of competition *
2. Leadership roles
3. Impact on athletic team success
4. Scholastic achievements *
5. All Ohio, District, County selections *
6. School, County, District, or State records *
7. All League selection *
8. Postgraduate achievements
9. Coaching achievements
10. Community achievements

* These criteria must be completed if nominee is an athlete.

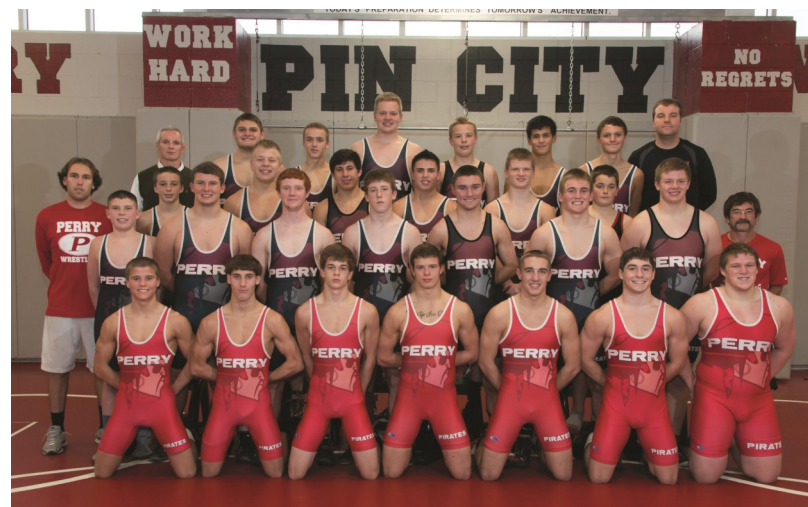

2014 Wrestling Team



The 2013-2014 Perry Pirates Wrestling team included athletes Jason Bellissimo, Ethan Bixel, Sam Cales, Seth Cales, Collin Dees, Geoffrey Gedeon, Aaran Gessic, Billy Hedrich, Kyle Kremiller, Dalton Marsey, David McDannel, Billy Miller, John Miller, David Mrosko, MJ Reed, Josh Romano, Nick Sbrocco, Alec Schenk, Evan Schenk, Ricky Seghetti, Brady Toth, Brandon Truhn, Connor VanDeweel, Jake Vicini, and Cameron Winters.

The 2014 Wrestling team finished overall with a 10-1 dual record. The team took fourth overall at the Brecksville Holiday Tournament and third at the Maumee Bay Classic. They were Pin City Champions, State Duals, Regional Champions, Chagrin Valley Conference Champions, and Sectional Champions. The team placed second at the District Tournament and fourth overall at the Individual State Tournament.

Seven of the wrestlers on the 2013-2014 team won more than 30 matches that year and had five Conference Champions and eight Sectional Champions. Seven wrestlers placed at Districts and four wrestlers placed at the State Tournament with one as State Champion. State placers were Aaran Gessic (3rd), Kyle Kremiller (4th), Alec Schenk (3rd) and Billy Miller (1st).

The 2012-2013 Perry Pirates Wrestling team included athletes Kyle Beyer, Ethan Bixel, Neil Brown, Seth Cales, Collin Dees, Geoffrey Gedeon, Aaran Gessic, Cory Gramberg, Kyle Homerick, Brock Hurd, Robbie Isabella, Drew Jones, Kyle Kremiller, Nick Lauria, John Miller, Billy Miller, David Mrosko, Evan Nichols, Cannan Perry, MJ Reed, Josh Romano, Nick Sbrocco, Alec Schenk, Ricky Seghetti, Ryan Sill, Brady Toth, Brandon Truhn, Connor VanDeweel, Jake Vicini, and Cameron Winters.

The wrestling team was 2013 OHSAA State Individual Tournament Runner-up, which at that time, was the highest placing team finish in Perry athletic history. Their 10-1 dual meet record made them Region 11 Champions in the first year of the OHSAA State Dual Tournament. The team also finished top ten in both the North Coast Classic and Brecksville Holiday tournaments. They placed second at the Maumee Bay Classic, were Perry Pin City Champions, Chagrin Valley Conference Champions, Sectional Champions and District Runner-up.

Perry qualified a record of 13 wrestlers to the District Tournament, had five State qualifiers all of which placed at the State Tournament, another Perry record. State placers were Aaran Gessic (5th), Collin Dees (4th), Evan Nichols (3rd), Alec Schenk (3rd) and Billy Miller (1st). Academically, the team had a GPA of 3.28 and achieved many academic and professional goals following graduation.

ATHLETIC ALUMNI HALL OF FAME HISTORY

The Perry Pirate Booster Club authorized the formation of a Hall of Fame Committee to honor Perry Athletes by developing a process to create an Alumni Athletic Hall of Fame.

In March of 1992, Perry Local Schools' Board of Education authorized the concept of the Perry Pirate Booster Club. The Club selected a committee and developed the guidelines for how the Hall of Fame would be established. The policies and procedures were approved by the Booster Club in the spring of 1992.

A committee and public nomination procedure was put into place during the fall of 1992. In January of 1993, 65 individuals qualified to be placed on a ballot for voting by the committee. The first induction class of 21 former Perry athletes, coaches, or community contributors was selected in May of 1993 after receiving sufficient votes for induction. Since its inception, the Hall of Fame committee has inducted a total of 122 athletes, administrators, coaches and six teams.

It is our hope that Perry's Athletic Hall of Fame not only honors the accomplishments of our inductees, but also serves to inspire future Perry High students to aspire to the accomplishments of those Hall of Famers who have built the fine tradition of Perry Athletics.

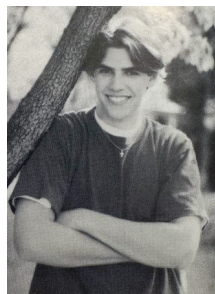
DISTINGUISHED ALUMNI HALL OF FAME HISTORY

In the spring of 2001, the Perry Board of Education established The Distinguished Alumni Hall of Fame to honor former students of Perry High School whose lives are exemplary for both their career accomplishments and their contributions to the well being of others. They have been selected because they have distinguished themselves in their field of study, career or community service. In addition, these individuals will serve as an inspiration to the students of Perry Local Schools, encouraging them to live their dreams and to pursue personal excellence in all future endeavors.

The members of the charter committee of the Distinguished Alumni Hall of Fame began their work early that year. Their task was to establish the policies and procedures that would guide the future selection of all Distinguished Alumni Hall of Fame inductees. These members were nominated by the Board of Education and represented a cross-section of school and community members.

After determining the nominating criteria and process, the final task of the Charter Committee was to recommend individuals to serve on the Selection Committee. This committee was also comprised of a diverse cross-section of people including representatives from the Perry Board of Education, the Perry Historical Society, school administration, staff, students, and community.

Steve Froehlich

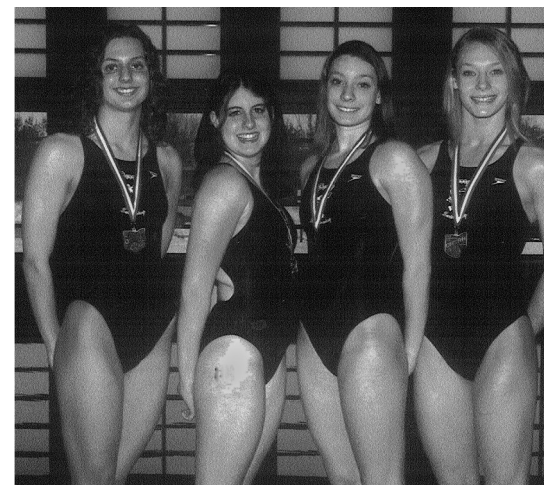


CLASS OF 1996

Steve Froehlich graduated Perry High School as valedictorian of the Class of 1996. Steve played JV soccer and was on the golf team, but was never really a good athlete. He was very passionate about video production and had a television show on PHS's cable access channel named "Off the Plank." During his junior year, Steve studied abroad as a foreign exchange student thru AFS to the Czech Republic.

After graduating, Steve attended American University in Washington, DC where he started his career as a nonprofit fundraiser. Over the past 25 years, Steve has worked for nonprofits that help with environmental protection, animal welfare, and domestic violence. He is currently serving as the Chief Revenue and Development Officer for St Jude Children's Research Hospital. During his time, he is credited with raising over \$15 billion in nonprofit donations.

2005 Girls 400 Yard Freestyle Swim Relay



The 2005 Perry High School Girls 400 Yard Freestyle Swim Relay Team consisted of junior Grace Andrews, junior Janelle Cain, senior Lindsey (Dorko) Lawson and senior Angela Inzano.

The relay team placed third at the OHSA 2005 Girls Division II Swimming and Diving Championships and broke the school record twice in the same day (3:40.54). By the final race, they had shaved seven seconds off their time from two weeks prior, and a second and a half from the morning preliminaries. That school record will turn 20 years old in February.

The relay was honored with a resolution recognizing their achievement from the Perry Township Board of Trustees. The PHS Girls Swim Team that season went 8-1 in the regular season and the relay was a finalist at several large area invitational including the CSU Viking Invitational and Canton Invite. In 2004, the previous year, the relay team had finished tenth in the OHSA State Championships

During their high school swimming tenure, each of the four girls achieved the following accomplishments, among many others: four-year varsity letter winners, *News-Herald* and *Plain Dealer* swimmers of the week, National Interscholastic Swim Coaches Association (NISCA) All America Swimming, Chagrin Valley Conference All-Academic, All-District, All-Ohio Academic, and Academic All-American. Both Janelle Cain and Lindsey (Dorko) Lawson went on to swim varsity for four years at Ohio Northern University and Wooster College, respectively.

The team was coached by Head Coach Fredy Arnold and Assistant Coach Connie Brothag.

Alec is a distinguished athlete whose career spans impressive achievements both in high school and college wrestling. At Perry High School, Alec was a four-time varsity letterman, serving as team captain his junior and senior years. Alec was a two-time State placer, placing third in 2013 and 2014. He was District Champion in 2013 and Chagrin Valley Conference Champion in 2012 and 2014. Alec was a four-time Pin City Champion and set the school record compiling 162 career wins. Alec was also named an AAU All-American in the Summer of 2014.

In Soccer, Alec was a four-year letter winner and was team captain for two of those years.

After high school, Alec continued his wrestling career at Duke University where he was a four-year starter from 2015-2019 and captained the team his junior and senior seasons. He was an ACC Academic Honor Roll recipient five times and achieved U23 Freestyle All-American status in 2018, finishing sixth.

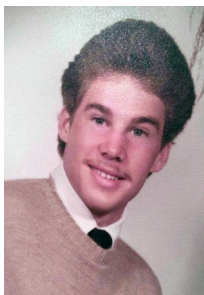

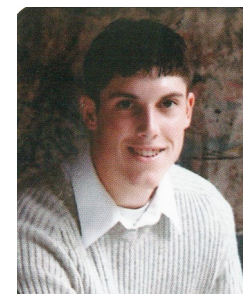

Michael Ryan was a standout three-sport athlete at Perry High School, excelling in football, baseball, and wrestling, and earning a total of eight varsity letters. As a pitcher and first baseman on the varsity baseball team, he helped secure three conference championships and led the team to the state semifinals during his senior year. That season, he led the area in pitching appearances and wins, finishing with a 10-2 record and recording 88 strikeouts. Notably, he threw a no-hitter in the first game of the season after a six-month recovery from ACL surgery, and later threw a one-hitter in the district semifinal against Chanel. At first base, he boasted a .456 batting average, collected 21 RBIs, and maintained a .984 fielding percentage.

Michael's breakout junior season saw him leading the area in multiple pitching categories. He finished with a 5-1 record, an impressive 0.91 ERA across more than 50 innings pitched, and a .349 batting average with 26 RBIs, earning him numerous post-season honors.

During his senior year, Michael earned First-Team honors from several organizations, including the Chagrin Valley Conference (CVC), *The News-Herald*, *The Plain Dealer*, Lake County Baseball Club, Northeast Ohio, and All-Ohio. He represented Perry at the Senior Mizuno All-Ohio Tournament and was selected to play for Team Ohio in the prestigious Sun Belt Classic in Norman, Oklahoma. His contributions to Perry's 2004 baseball team helped secure their place in the Perry Athletic Hall of Fame in 2014.

Beyond baseball, Michael earned three varsity letters in football. As a junior, he was selected to the First-Team All-CVC, First-Team Lake County Touchdown Club, First-Team Great Lakes District, and Honorable Mention All-Ohio. Despite being named captain his senior year, his season was cut short by an ACL injury. Michael also wrestled during his junior year, earning a varsity letter, placing third in the CVC Tournament, and qualifying for the District Tournament.

Equally accomplished in the classroom, Michael was a member of the National Honor Society. After graduating, he went on to play baseball at Marietta College and California University of Pennsylvania. Today, Michael serves as the Associate Athletic Director at Avon High School, where he continues to strive to positively impact student-athletes.

Tom Trenney



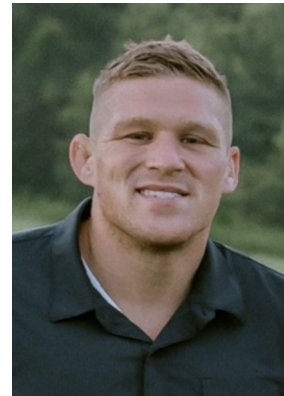
CLASS OF 1995

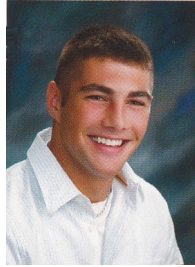

In his sophomore year of football Anthony received honors of 2nd Team Chagrin Valley Conference (CVC), All-Ohio Special Mention and Northeast Lakes District 1st Team. In his junior season, Anthony was named 1st Team CVC, and All-Ohio Special Mention. In Anthony's senior season he was named All-Ohio 2nd Team, as well as 1st Team CVC, and Lake County Touchdown Club Offensive All-Star.

On the basketball court Anthony received CVC Honorable Mention his sophomore year and 1st Team CVC his junior and senior seasons. In Anthony's junior season he was named team MVP and 2nd Team All-Ohio. Michael was a two-year starter for the Perry Pirates varsity football team as a running back and safety. Michael was selected 1st Team All-Ohio Running Back, the Associated Press Lakes Region Player of the Year, Chagrin Valley Conference (CVC) Most Valuable Player, and named to the *News-Herald* All-Star Team. Michael was the recipient of the Tony Fisher Award, which is given to the Most Valuable Player in the *News-Herald* coverage area. He was also recognized as the Lake County Touchdown Club's Offensive Player of the Year.
