The meeting will begin promptly at 10:00 a.m. with the first section which is called Audience Comments. The Audience Comment portion of the agenda is where individuals may comment on matters that concern the District. Each individual is limited to three (3) minutes for such comment. The Board of Supervisors or Staff is not obligated to provide a response until sufficient time for research or action is warranted. IF THE COMMENT CONCERNS A MAINTENANCE RELATED ITEM, THE ITEM WILL NEED TO BE ADDRESSED BY THE DISTRICT MANAGER OUTSIDE THE CONTEXT OF THIS MEETING. The second section is called Staff Reports. This section allows the District Manager, Engineer, and Attorney to update the Board of Supervisors on any pending issues that are being researched for Board action. The third section is called Business Administration. The Business Administration section contains items that require the review and approval of the District Board of Supervisors as a normal course of business. The fourth section is called Business Items. The Business Items section contains items for approval by the District Board of Supervisors that may require discussion, motion and votes on an item-by-item basis. Occasionally, certain items for decision within this section are required by Florida Statute to be held as a Public Hearing. During the Public Hearing portion of the agenda item, each member of the public will be permitted to provide one comment on the issue, prior to the Board of Supervisors' discussion, motion and vote. Agendas can be reviewed by contacting the Manager's office at (813) 933-5571 at least seven days in advance of the scheduled meeting. Requests to place items on the agenda must be submitted in writing with an explanation to the District Manager at least fourteen (14) days prior to the date of the meeting. The final section is called **Supervisor Requests**. This is the section in which the Supervisors may request Staff to prepare certain items in an effort to meet residential needs.

Public workshops sessions may be advertised and held in an effort to provide informational services. These sessions allow staff or consultants to discuss a policy or business matter in a more informal manner and allow for lengthy presentations prior to scheduling the item for approval. Typically, no motions or votes are made during these sessions.

Pursuant to provisions of the Americans with Disabilities Act, any person requiring special accommodations to participate in this meeting is asked to advise the District Office at (813) 933-5571, at least 48 hours before the meeting. If you are hearing or speech impaired, please contact the Florida Relay Service at 7-1-1, who can aid you in contacting the District Office. A RESOLUTION OF THE BOARD OF SUPERVISORS ("BOARD") OF THE WATERFORD COMMUNITY DEVELOPMENT DISTRICT (THE "DISTRICT") DECLARING PHASE ONE OF THE SERIES 2023 PROJECT COMPLETE AND ADOPTING THE ENGINEER'S CERTIFICATE OF COMPLETION FOR THE PHASE ONE COMPONENT OF THE SERIES 2023 PROJECT; FINALIZING THE SERIES 2023 SPECIAL ASSESSMENTS FOR THE PHASE ONE COMPONENT OF THE SERIES 2023 PROJECT; AND ADDRESSING SEVERABILITY, CONFLICTS AND AN EFFECTIVE DATE.

WHEREAS, the Waterford Community Development District (the "**District**") was established by Hernando County, Florida to construct, acquire, install, operate and/or maintain systems and facilities for the public infrastructure described in the Engineer's Report for Waterford Community Development District dated June 1, 2022 (the "**Engineer's Report**"); and

WHEREAS, the District duly authorized and intends to issue its Waterford Community Development District Capital Improvement Revenue Bonds, Series 2023 (Assessment Area One) (the "Series 2023 Bonds") for the purpose of funding the construction, installation, and acquisition of the public infrastructure described in the Engineer's Report (the "Series 2023 Project"); and

WHEREAS, in order to repay the Series 2023 Bonds, the District levied special assessments securing the Series 2023 Bonds (the "Special Assessments") as described in the Waterford Community Development District Master Special Assessment Allocation Report dated July 1, 2022; and

WHEREAS, Phase One of the Series 2023 Project, as defined in the Engineer's Report, specially benefits certain assessable lands in the District which are subject to the Special Assessments, and it is reasonable, proper, just and right to continue to assess the costs of the Phase One component of the Series 2023 Project financed with the Series 2023 Bonds to the specially benefited properties; and

WHEREAS, effective as of the date of this Resolution, the Board of Supervisors further finds that it is in the best interests of the District to declare the Phase One component of the Series 2023 Project complete; and

WHEREAS, as set forth in the Engineer's Certificate of Completion attached as Exhibit "A", the District Engineer has certified the Phase One component of the Series 2023 Project complete; and

WHEREAS, in reliance upon the Engineer's Certificate of Completion, and to be effective as of the date of this Resolution, the Board of Supervisors of the District desires to certify the Phase One component of the Series 2023 Project complete; and

WHEREAS, Section 170.08 Florida Statutes requires that upon completion of Phase One of the Series 2023 Project, the District is to credit each of the Special Assessments the difference, if any, between the amount assessed and the actual cost of the improvements; and

WHEREAS, based on the Engineer's Certification of Completion, no modification to the Special Assessments for the Phase One component of the Series 2023 Project are necessary.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE WATERFORD COMMUNITY DEVELOPMENT DISTRICT:

SECTION 1. RECITALS. The recitals stated above are incorporated herein and are adopted by the Board as true and correct statements.

SECTION 2. GENERAL AUTHORITY. This resolution is adopted pursuant to the Indenture and provisions of Florida law, including Chapters 170 and 190, Florida Statutes.

SECTION 3. COMPLETION OF PHASE ONE OF THE SERIES 2023 PROJECT AND FINALIZATION OF THE SPECIAL ASSESSMENTS. Based on the Engineer's Certificate attached as Exhibit "A", and the above findings incorporated herein, and to be effective as of the date of this Resolution, the Board hereby adopts the Engineer's Certificate of Completion and hereby certifies the Phase One component of the Series 2023 Project complete and determines that no modifications to the Special Assessments are necessary for the Phase One component of the Series 2023 Project.

SECTION 4. GENERAL AUTHORIZATION. The District's Chair, Vice Chair, Secretary, Assistant Secretaries, District Manager, District Counsel, District Engineer, and District Bond Counsel, are hereby authorized, upon the adoption of this Resolution to do all acts and things required of them to effect the transactions described herein, and all acts and things that may be desirable or consistent with the requirements or intent hereof. The Chair and Secretary are hereby further authorized to execute any and all documents necessary to effect the transactions. The Vice Chair shall be authorized to undertake any action herein authorized to be taken by the Chair, in the absence or unavailability of the Chair, and any Assistant Secretary shall be authorized to undertake any action herein authorized to be taken by the Secretary, in the absence or unavailability of the Secretary.

SECTION 5. SEVERABILITY. I. Introduction

The purpose of this report is to supplement the Engineer's Report dated June 1, 2022 (the "Master Report") for the Waterford Community Development District (the "District"). The Master Report generally describes the overall public capital improvement plan (the "CIP") anticipated to be developed within the District. This report focuses on the portion of the CIP that will be financed by the Series 2023 Bonds to be issued by the District (the "2023 Project"). For detailed descriptions of the improvements to be financed by the District, including those improvements constituting the 2023 Project, please refer to the Master Report.

The 2023 Project will benefit the Phase 1 and 2 lands within the District planned for 196 residential units as shown in **Exhibit A**.

II. Opinion of Probable Construction Costs

Table 1 presents a summary of the actual and probable construction costs for the 2023 Project serving the District.

It is my professional opinion that the infrastructure costs provided herein for the District's improvements are reasonable to complete the construction of the infrastructure described herein and that these infrastructure improvements will benefit and add value to the District. All such infrastructure costs are public improvements or community facilities as set forth in Section 190.012(1) and (2) of the Florida Statutes.

The estimate of infrastructure construction costs is only an estimate and not a guaranteed maximum price. The estimated cost is based on unit prices currently being experienced for ongoing and comparable items of work in Hernando County and quantities as represented on the construction plans.

The labor market, future costs of equipment and materials, increased regulatory actions and the actual construction process are all beyond control. Due to this inherent opportunity for fluctuation in cost, the total final cost may be more or less than this estimate.

Assuming project construction continues in a timely manner, it is our opinion that the proposed improvements, if constructed in substantial accordance with approved plans and specifications, can be completed and meet their intended function. Where necessary, historical data, in relation to costs, as well as expertise from other professionals (utility consultants and contractors) has been considered in preparation of this report. Consultants and contractors who have contributed their professional opinion regarding cost data to this report are reputable entities within the Hernando County area. It is therefore our opinion that the construction of the proposed project can be completed at the costs, as stated.

I. INTRODUCTION

This Preliminary Supplemental Special Assessment Allocation Report is being presented in anticipation of an issuance of bonds by the Waterford Community Development District ("District"), a local unit of special purpose government established pursuant to Chapter 190, Florida Statutes. Rizzetta & Company, Inc. has been retained to prepare a methodology for allocating the special assessments related to the District's infrastructure project. This report will detail the preliminary financing and assessment allocation of the Series 2023 Bonds expected to fund the District's Assessment Area One Project.

II. DEFINED TERMS

- "Assessment Area One" An assessment area within the District consisting of 118 platted residential units in phase 1 and 26.32 acres in phase 2, benefitted by the Assessment Area One Project.
- "Assessment Area One Assessments" The special assessments, as contemplated by Chapter 190 and Chapter 170, Florida Statutes, that are levied to secure repayment of the District's Series 2023 Bonds.
- "Assessment Area One Project" A portion of the CIP with an estimated cost of \$9,994,500 as shown in the Supplemental Engineer's Report (Series 2023 Bonds) dated December 9, 2022 and prepared by the District Engineer.
- "Capital Improvement Program" (or "CIP") The District's comprehensive plan for constructing and/or acquiring the District-wide system of public infrastructure improvements, all or a portion of which may be funded by the proceeds of District bonds.
- "Developer" Oak Hill Land, LLC
- "District" Waterford Community Development District.
- "District Engineer" Coastal Engineering Associates, Inc.
- **"End User"** The ultimate purchaser of a fully developed residential unit; typically, a resident homeowner.
- **"Engineer's Report"** Refers to the *Master Engineer's Report* Dated June 1, 2022 as amended by *Supplemental Engineer's Report (Series 2023 Bonds)* dated December 9, 2022, each prepared by the District Engineer.



"Equivalent Assessment Unit" – (or "EAU") Allocation factor which reflects a quantitative measure of the amount of special benefit conferred by the District's CIP on a particular land use, relative to other land uses.

"Indentures" – The District's Master Trust Indenture and First Supplemental Trust Indenture, both dated January 1, 2023.

"Master Report" – The Master Special Assessment Allocation Report, dated July 1, 2022.

"Platted Units" – Lands configured into their intended end-use and subject to a recorded plat.

"Series 2023 Bonds" – The \$4,835,000 (estimated) Capital Improvement Revenue Bonds, Series 2023 (Assessment Area One).

"True-Up Agreement" – The Agreement to be executed between the District and the Developer, regarding the True-Up and Payment of the Assessment Area One Assessments.

"Unplatted Parcels" – Undeveloped lands or parcels not yet subject to a recorded plat in their final end-use configuration.

All capitalized terms not defined herein shall retain the meaning ascribed in the Master Report.

III. DISTRICT INFORMATION

The District was established effective May 11, 2022, pursuant to Hernando County Ordinance No. 2022-12. The District encompasses approximately 296.36 +/- acres and is located entirely within unincorporated Hernando County. The current development plan for Assessment Area One of the District includes 118 Platted Units in phase one and approximately 26.32 acres or 78 planned units in phase 2.

Table 1 illustrates the District's Preliminary Development Plan for Assessment Area One.

IV. Capital Improvement Program

The District's Capital Improvement Program for Assessment Area One includes, but is not limited to, general conditions, clearing/grubbing/earthwork, stormwater management, roads, sanitary sewer, dry utilities, water facilities, landscaping/hardscaping/irrigation, and recreational amenities. The total cost of the Assessment Area One Project is estimated to be \$9,994,000 as described in the Supplemental Engineer's Report (Series 2023 Bonds) dated December 9, 2022. A detail of these costs can be found in Table 2. The District expects to issue the Series 2023 Bonds to fund a portion of the Assessment Area One Project in the estimated amount of \$4,066,168.



V. Series 2023 Bonds and Assessments

In order to provide for the Assessment Area One Project funding described in Section IV above, the District will issue the Series 2023 Bonds in the estimated principal amount of \$4,835,000, which will be secured by the pledged revenues from the Assessment Area One Assessments. The Assessment Area One Assessments will initially be levied in the estimated amount of \$351,257 and shall be structured in the same manner as the Series 2023 Bonds, so that revenues from the Assessment Area One Assessments are sufficient to fulfill the debt service requirements for the Series 2023 Bonds.

The Series 2023 Bonds will be structured as amortizing current-interest bonds, with repayment occurring in thirty (30) substantially equal annual installments of principal and interest, excluding any capitalized interest. Interest payment dates shall occur every May 1 and November 1 until final maturity on May 1, 2053. The first scheduled payment of coupon interest will be due on May 1, 2023, although interest will be capitalized through May 1, 2023, with the first installment of principal due on May 1, 2024. The annual principal payment will be due each May 1 thereafter until final maturity. The maximum annual debt service (MADS) is estimated to be \$351,257.

It is expected that the Assessment Area One Assessments will initially be levied on the 118 Platted Units in phase one and the approximately 26.32 remaining gross acreage in phase 2, within Assessment Area One. Assessment Area One Assessments will only be assigned to the remaining lots once they are platted. Assessment Area One Assessments assigned to the Platted Units will be collected via the Hernando County property tax bill process (Uniform Method). Accordingly, the Assessment Area One Assessments have been adjusted to allow for current county collection costs and the possibility that landowners will avail themselves of early payment discounts. Currently, the aggregate rate for such costs and discounts is 8.0%, but this may fluctuate as provided by law. The unplatted parcels are expected to be collected directly by the District and will not include any county collection costs or early payment discounts. However, for purposes of this report, all units are inclusive of the associated costs and discounts for presentation purposes only.

VI. ASSESSMENT AREA ONE ASSESSMENT ALLOCATION

The District's Master Report contains specific special benefit findings relative to the Maximum Assessments and the District's CIP. As stated therein, the CIP costs per unit and Maximum Assessments were allocated pursuant to an EAU-based methodology.

Per Section IV above, the Series 2023 Bonds will fund a portion of the District's Assessment Area One Project, which is expected to be constructed in a manner generally proportionate to the construction of improvements for the CIP. Accordingly, it is expected that the improvements funded by the Series 2023 Bonds will confer benefit on the District's

developable parcels in a manner generally proportionate to and consistent with the allocation of benefit found in the Master Report.

A. Assessment Area One Assessment Allocation

The Assessment Area One Assessments are expected to ultimately be allocated to the units shown on Table 5 using target annual assessments provided by the Developer. As allocated, the Assessment Area One Assessments fall within the cost/benefit thresholds, as well as the Maximum Assessment levels, established by the Master Report. The District will recognize in-kind contributions of infrastructure by the Developer in the estimated amount of \$579,350 as an assessment credit to the lots in phase 1 specified in Table 6, in order to reach target assessment levels. See Table 6 for the contribution calculation.

Table 5 reflects the estimated Assessment Area One Assessments per Platted Unit. It is expected that the Assessment Area One Assessments will initially be levied on the 118 Platted Units in phase one and the approximately 26.32 remaining gross acreage in phase 2, within Assessment Area One, on an equal assessment per acre basis. As land is either sold in bulk to third parties, or as land is platted or otherwise subdivided in Platted Units, the Assessment Area One Assessments will be assigned to the gross acres as described in the Master Report or assigned to those Platted Units at the per-unit amounts described in Table 5, on a first platted and first assigned basis, thereby reducing the Assessment Area One Assessments encumbering the Unplatted Parcels by a corresponding amount. The Assessment Area One Assessments are expected to be assigned to 196 Platted Units.

As allocated, the Assessment Area One Assessments fall within the cost/benefit thresholds, as well as the Maximum Special Assessment levels, established by the Master Report, and are fairly and reasonably allocated among the different product types.

In the event an Unplatted Parcel is sold to a party not affiliated with the Developer, Assessment Area One Assessments will be assigned to that Unplatted Parcel based on the maximum total number of Platted Units assigned by the Developer to that Unplatted Parcel. The owner of that Unplatted Parcel will be responsible for the total assessments applicable to the Unplatted Parcel, regardless of the total number of Platted Units ultimately platted. These total Assessment Area One Assessments are fixed to the Unplatted Parcel at the time of the sale. If the Unplatted Parcel is subsequently sub-divided into smaller parcels, the total assessments initially allocated to the Unplatted Parcel will be re-allocated to the smaller parcels pursuant to the methodology as described herein (i.e., equal assessment per acre until platting).

The Series 2023 Preliminary Assessment Roll is located on page A-6.



VII. PREPAYMENT AND TRUE UP OF ASSESSMENT AREA ONE ASSESSMENTS

The Assessment Area One Assessments encumbering a parcel may be prepaid in full or in part at any time, without penalty, together with interest at the rate on the Series 2023 Bonds to the Interest Payment Date (as defined in the Indenture) that is more than forty-five (45) days next succeeding the date of prepayment. Notwithstanding the preceding provisions, the District does not waive the right to assess penalties which would otherwise be permissible if the parcel being prepaid is subject to an assessment delinquency.

Because this methodology assigns defined, fixed assessments to Platted Units, the District's Assessment Area One Assessment program is predicated on the development of lots in the manner described in Table 1. However, if a change in development results in net decrease in the overall principal amount of assessments able to be assigned to the lands described in Table 1, then a true-up, or principal reduction payment will be required to cure the deficiency ("True Up Payment"). The District shall perform a review of the development plan for true-up calculation purposes at each time any plat/site plan is presented to the District. For further detail on the true-up process, please refer to the True-Up Agreement. Similarly, if a reconfiguration of lands or redemption of outstanding Series 2023 Bonds would result in the collection of substantial excess assessment revenue in the aggregate, then the District shall undertake a pro rata reduction of assessments for all assessed properties.

For further detail on the true-up process, please refer to the True-Up Agreement and applicable assessment resolution(s).

VIII. ADDITIONAL STIPULATIONS

Certain financing, development, and engineering data was provided by members of District staff and/or the Developer. The allocation methodology described herein was based on information provided by those professionals. Rizzetta & Company, Incorporated makes no representations regarding said information beyond restatement of the factual information necessary for compilation of this report. If there is anything contained in the Master Report that is inconsistent with the provisions of this report, the provisions of this report shall govern. For additional information on the Series 2023 Bond structure and related items, please refer to the Preliminary Limited Offering Memorandum associated with this transaction.
