Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2024-25 Opportunities for Parental Involvement

The staff at Mendocino County Community School implements procedures and protocols that encourage parent participation. During student intake/enrollment, parents are an integral component of the meeting as they enroll their student and become familiar with the staff and the site. During this time our Schoolwide Learner Outcomes, Rules/Expectations, academic/behavioral/attendance history is reviewed with both the parent and student. When students are beginning their transition back to their district of residence, parents are also involved in the transition plan which includes meetings with the school counselor and principal. All staff have an open door policy and much contact is made when students arrive or depart from the school site. Parent outreach occurs each day regarding student absences, concerns about student behavior or positive anecdotes. The principal, school counselor and student accountability specialist communicate with parents on a daily basis. Parents are invited to attend School Site Council and LCAP Stakeholder meetings. Parent input and concerns are actively cultivated through surveys that are initiated through telephone, text, email and general mail delivery. Parents are strongly encouraged to contact the school's principal, counselor, administrative secretary/registrar and the school accountability specialist at any time with questions or concerns.

2024-25 School Safety Plan

The safety plan for Mendocino County Community School is included in the overall plan that has been created for all sites that operate through the Mendocino County Office of Education. The safety plan for Mendocino County Community School was updated August 2022 with requested input from staff, students and parents. All staff has immediate access to the plan. Key elements of the plan include protocols and procedures for emergency/disaster drills including Room Clear, Lockdown, Quarantine and Public Safety Power Shut-Off. All staff members are required to successfully complete on-line trainings including Child Abuse Reporting, Germ and Pest Management, Youth Suicide: Awareness, Human Trafficking Awareness, Illness and Injury Prevention. In preparation for on site emergencies, all classrooms are provided with portable 'bucket' facilities, emergency backpacks, first aid kits and communication devices. The School Safety Plan was reviewed by the Safety Committee in December 2023 and will be ready for board review in January 2024. The plan is scheduled to be reviewed, updated, and discussed with school faculty and a student representative on February 15, 2025.

Professional Development

Teachers attend four professional development days prior the the start of the school year, two embedded during the year and one at the end of the school year. Throughout the academic year, one day weekly is also used for staff meetings, professional development and Professional Learning Community meetings. Meetings dedicated to the Professional Learning Community take place once per month.

Through the WASC accreditation process, the staff identified specific areas of professional development designed to

accompany our identified objectives and goals. This process provided a venue for staff to voice areas of need and request levels of support. The primary areas of professional development follow the identified goals and objectives increasing student achievement and developing and sustaining authentic relationships. The primary areas of focus regarding increasing student achievement include basic understanding of and curricular implementation of Common Core State Standards, highly effective instructional strategies, research based student engagement practices, and increasing rigor and student voice in the classroom. The primary area of focus regarding developing and sustaining authentic relationships includes the larger topic of social emotional triage (trauma informed practices, restorative practices) as determined by staff as to what is predominately our greatest area of need.

Professional development is provided through instructional readings/book clubs, online conferences, virtual trainings and small group research into demonstrated areas of need. Staff meetings are used to provide support for the trainings, discuss implementation models and review effectiveness.
