Item # 14 – Fyfield Court – Dog station refill. Weekly refill will be confirmed and a map given again to the crew/porter.

Item # 15 – Irrigation at the corner of Clover Blossom and Mentmore- this will be checked once the new well is connected.

Item # 20 - Tree crew has been notified and they will trim when they come to trim the trees on the back side of the pond on Clover Blossom.

Item # 23 - Fieldstone doesn't service this park on Prairie Iris.

Item # 29- 1 viburnum will be replaced, would like to do it when we do the remaining monument plant installations.

Cut the edge of the existing sod along the bed on the side closest to the viburnum (both sides of new hedge)

Straight line

This will straighten the sod line and reduce the size of the bed, control weeds and finish the look of the new bed.

Check and set irrigation to water new sod

After installation apply fungicide, insecticide and fertilizer.
