#### 2014/2015 Summer Improvements (phase 2)

The Administration and Fanning/Howey will discuss the Project Scope that has been prepared and presented thus far for "Phase 2" of the proposed improvement projects at Field Elementary School. In addition, the preliminary budget estimate and preliminary project schedule will be discussed. The intent will be to request that the Board move forward with the development of design documents for this work at the Regular Board Meeting on April 22, 2013.

- 1) Carpeting the LRC due to the asbestos removal around the existing uni-vents at an estimated cost of \$9,000.00.
- 2) Window caulking will need to be done if the District does not replace the windows at an estimated cost of \$43,000.00.




