# Minutes of the Special Board Meeting held at 7:30 p.m. April 19, 2010 Hendee Educational Service Center 164 S. Prospect Avenue

#### APPROVAL OF SUPERINTENDENT

Mr. Heyde reviewed the steps in the extensive search process conducted over much of the past year with assistance from Dr. Sam Mikaelian and Dr. Alan Leis of Hazard, Young, Attea & Associates to identify an outstanding new leader for District 64 upon the retirement of Dr. Sally Pryor on June 30. He introduced Philip V. Bender, Ph.D., as the Board's choice to lead the District; Dr. Bender is currently superintendent of New Prairie United School Corp. in Indiana. Mr. Heyde offered highlights of Dr. Bender's educational career and professional accomplishments, and commented on the positive impressions formed during a site visit with Mr. Fioretto to his district as well as during Dr. Bender's reciprocal visit here. Mr. Fioretto confirmed the favorable findings of the site visit. Mr. Heyde stated that Board members believed Dr. Bender meets the demanding criteria identified in the leadership profile, which all members of the community had been invited to help formulate. He then expressed the Board's appreciation to Dr. Pryor for her service to District 64 and noted that she is leaving the District in enviable position, both financially and academically.

It was moved by Board member Gentile and seconded by Board member Smart that the Board of Education of Community Consolidated School District 64, Park Ridge-Niles, Illinois approve the appointment of Philip V.
