Niles Elementary School District 71 would like to utilize <u>Google Apps for Education</u> for students, teachers, and staff. This permission form describes the tools and student responsibilities for using these services. As with any educational endeavor, a strong partnership with families is essential to a successful experience.

The following services are available to each student and hosted by Google as part of Niles Elementary School District 71's online presence in Google Apps for Education:

- Email an individual email account for school use only, managed by Niles Elementary School District 71
- Calendar an individual calendar providing the ability to organize schedules, daily activities, and assignments
- Docs/Drive a word processing, spreadsheet, drawing, and presentation toolset that is very similar to Microsoft Office

Using these tools, students collaboratively create, edit and share files and websites for school related projects and communicate via email with other students and teachers. Google Apps for Education is available at home, the library, or anywhere with Internet access. School staff will monitor student use of Apps when students are at school. Parents are responsible for monitoring their child's use of Apps when accessing programs from home. Students are responsible for their own behavior at all times. Examples of student use include; showcasing class projects, building an electronic portfolio of school learning experiences, and working in small groups on presentations to share with others.

## Technology use in Niles Elementary School District 71 is governed by federal laws including:

## Children's Online Privacy Protection Act (COPPA)

By default, advertising is turned off for Niles Elementary School District 71's presence in Google Apps for Education. No personal student information is collected for commercial purposes. This permission form allows the school to act as an agent for parents in the collection of information within the school context.
