#### **Superintendent Reports**

#### Report #1001 Dental Smiles Dental Program Board Goal 3

Dr. Anderson shared information about a dental program offered by Dental Smiles for check-ups for students in grades prek-12. This program is covered through a state reimbursement to the Dental Smiles office, so it would be of no cost or liability to the District. The Board discussed the procedures and parental approvals with Lena Halikias, CEO of Dental Smiles . Dr. Anderson will work with Dental Smiles for possible school visits in the future.

# Report #1002 Buildings and Grounds Update Board Goal 1.c.1)

Dr. Anderson and Mr. Zelek shared the latest information about projects around the district for Elm Middle School's front entrance, possible lights projecting on the name of the high school on the new addition, entrance steps at Elmwood School, and resurfacing the district schools' parking lots. In addition, they shared the recommendation of the Building and Grounds Committee concerning a change to the District's facility use administrative procedures (8:20-AP) which requests a fee from non-school youth sports programs to use the outdoor facilities at the high school.

#### Report #1003 Board Policies from IASB - Second Reading Board Goal 3.

Dr. Anderson and members of the Policy Committee shared recent responses from IASB PRESS PLUS concerning our corrections noted at the November Board meeting. One area that we are unable to change completely involves staff members on military leave and how their time counts toward time in the District. This item requires a legislative change in wording, so we should approve the wording as it stands and then address any future legal changes when they come up.

#### Report #1004 2016-2017 District Calendar Proposal—First Reading Board Goal 3

Mr. Noyes presented the work of the District Calendar and Professional Development Committee. He outlined the process used to develop the calendar and the reasoning behind various decisions.

#### Report #1005 Web/Media Content Editor Position Discussion Board Goal #3a.2)

Mr. Kinane presented his candidate to fill the new position of Web/Media Specialist for the District. This position was approved last spring and the administration is recommending in the Personnel Report to hire Mr. David Porreca. He will be based at the high school and travel to all schools as needed.

#### Report #1006 PARCC/5Essentials Update Board Goal 2

The Illinois State e-Report cards have now been released, including PARCC scores from the 2015 testing. Unfortunately, score mistakes are numerous and ISBE has been swamped in helping districts make corrections or find reasons for "odd" scores and participation rates. Therefore, Dr. Anderson shared information about this process and why the District is not comfortable putting much emphasis on these scores at this time. We hope that the scores will eventually be corrected at a future date. Dr. Anderson discussed the upcoming presentations in January by building principals concerning the 5Essentials school climate survey conducted in 2015.
