RENTAL RELEASE EQUIPMENT RENTAL AGREEMENT AND LIABILITY RELEASE			EMAIL

1. I accept for use, as is, the equipment listed here. I understand that I may incur further charges, up to full retail replacement, if the equipment is late, damaged, or not returned by the agreed date.
2. I have made no misrepresentations concerning my height, weight, age, or skier type (alpine only), I understand that the bindings are adjusted for me personally and that use by anyone else may cause or increase the risk of injury.
3. I understand that the ski-boot-binding systems and helmets cannot guarantee the user's safety. In downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death nor is it possible to predict every situation in which it will release. In the case of a helmet rental, I understand that helmets have limits, no helmet can protect the wearer against all foreseeable impacts and injuries to the head. Helmets will not protect against rotational injury, neck, cervical, spine, and offer no protection for parts of the head and body they do not cover.
In snowboarding, snowshoeing, cross-country skiing and telemark skiing, the binding system will NOT ordinarily release during use; these bindings are not designed or intended to release as a result of forces generated during ordinary operation.
4. I understand that the sports of skiing, snowboarding, snowshoeing, telemark skiing and other similar recreational activities involve inherent and other risks of INJURY and DEATH. I voluntarily agree to EXPRESSLY ASSUME ALL RISKS OF INJURY OR DEATH that may result from skiing/snowboarding/telemark skiing, or which relate in any way to the use of this equipment, and any of the ski area facilities.
5. In consideration for services received, and to the fullest extent allowed by law, I RELEASE, INDEMNIFY, AND HOLD HARMLESS, New Mission LLC dba Mission Ridge Ski and Board Resort, and the manufacturers and distributors of this equipment, their owners, officers, employees, and agents from all claims and liabilities which may arise from the installation, maintenance, selection, adjustment, or use of this equipment, and any use of the ski area facilities.
6. If I am signing on behalf of a minor, I accept full responsibility for all medical expenses incurred as a result of the minor's use of this equipment and the ski area facilities, and I agree to RELEASE, INDEMNIFY, AND HOLD HARMLESS, to the fullest extent allowed by law, New Mission LLC dba Mission Ridge Ski and Board Resort, and the manufacturers and distributors of this equipment, their owners, officers, employees, and agents from any claims brought by or on behalf of the minor.
7. This document is a legally binding contract which supersedes any other agreements or representations by or between the parties and which is intended to provide a comprehensive RELEASE OF LIABILITY, but it is not intended to assert any claims or defenses which are prohibited by law. If any part of this Release is deemed unenforceable, all other parts will be given full force and effect.
8. I agree to abide by Washington State Law, "Your Responsibility Code" and all other ski area policies.
9. This release shall be governed by and interpreted in accordance with the laws of the State of Washington. Exclusive jurisdiction and venue for any legal proceedings related to this Agreement shall be in the state court for Chelan County, Washington or in the United States Federal Court for the Eastern District of Washington
10. If this equipment is to be used by someone other than me, I certify that I am acting as an agent for the user, that I have provided accurate and necessary information regarding the user for any binding adjustment or equipment selection, and that I will provide this form and all pertinent warnings and information to the user. I HAVE READ, UNDERSTAND AND ACCEPT AS LEGALLY BINDING THE TERMS OF THE ABOVE EQUIPMENT RENTAL AGREEMENT AND RELEASE OF LIABILITY.

LESSON RELEASE

AUTHORIZATION FOR MEDICAL TREATMENT and RELEASE OF LIABILITY

I understand that my child or ward ("the minor") may be in need of medical aid, assistance, treatment or care while at Mission Ridge and I authorize New Mission LLC dba Mission Ridge Ski and Board Resort to obtain, on behalf of the minor, all necessary medical aid, assistance, treatment or care provided to the minor by health care providers selected by New Mission LLC dba Mission Ridge Ski and Board Resort as a result of this Authorization.

I RELEASE, INDEMNIFY and HOLD HARMLESS New Mission LLC dba Mission Ridge Ski and Board Resort, and its owners, employees, agents, affiliates, and insurers from any claim for damages which occur to the minor or to me as a result of any medical aid, assistance, treatment or care provided to the minor by health care providers selected by New Mission LLC dba Mission Ridge Ski and Board Resort as a result of this Authorization.

I am aware that skiing/snowboarding and other similar activities are hazardous sports that include certain risks and dangers, including the risk of serious injury or death. I VOLUNTARILY ACCEPT FULL RESPONSIBILITY FOR ALL RISKS INVOLVED, including risks inherent in skiing/snowboarding and in the ski area/mountain environment.

I accept responsibility to ski/snowboard safely at all times, to abide by Your Responsibility Code, and to obey all posted behavior notices and any other ski area rules and policies. Any equipment used while skiing/snowboarding, I use at my own risk.

If I am signing on behalf of a minor, I understand and agree that during the course of a lesson, the minor may ride the chair or surface lifts. The minor may be paired with a Mission Ridge employee, volunteer, adult guest, another student, or may ride the chairlift alone.

I agree to RELEASE, HOLD HARMLESS, and INDEMNIFY Mission Ridge Ski School, New Mission LLC dba Mission Ridge Ski and Board Resort, and any of their officers, employees, agents, contractors, or subsidiaries, from all claims for any injury or damage resulting from any cause including negligence, which arise out of my or the minor's participation in or travel to and from Mission Ridge Ski School or any use of the ski area facilities. This RELEASE is also binding as to any other persons including all family members, heirs and executors.

This release shall be governed by and interpreted in accordance with the laws of the State of Washington. Exclusive jurisdiction and venue for any legal proceedings related to this Agreement shall be in the state court for Chelan County, Washington or in the United States Federal Court for the Eastern District of Washington

If I am signing on behalf of a minor, I accept full responsibility for all medical expenses incurred as a result of the minor's participation in or travel to and from Mission Ridge Ski School, New Mission LLC dba Mission Ridge Ski and Board Resort, from any claims brought by or on behalf of the minor.
