STUDENT CONDUCT ON BUSES (TRS-P004)

WENATCHEE SCHOOL DISTRICT

1.0 SCOPE:

1.1 This outlines the procedure to follow when misconduct by a student is detrimental to the safe operation of the bus and may be sufficient cause for a principal to suspend the transportation privilege.

The online version of this procedure is official; therefore, all printed versions are unofficial copies.

2.0 RESPONSIBILITY:

2.1 Director of Transportation, Bus Driver, Building Principal

3.0 APPROVAL AUTHORITY:

3.1 Director of Transportation

4.0 DEFINITIONS:

4.1 Policy 8123 – Written District Policy on Student Conduct on Buses

5.0 PROCEDURE:

- 5.1 The bus driver has the same authority as a classroom teacher since the bus is considered an extension of the classroom. The bus driver may handle situations without formal reports as he/she deems necessary or with help from the Transportation Department.
- 5.2 In the event, a bus driver has repeatedly given verbal warnings to a student and/or the bus driver feels the need to document the conduct issue, this procedure is followed.
- 5.3 The appropriate form is completed by the bus driver based on the student's grade level. For K-8, the Make Your Day form is completed. For grades 9-12, the Bus Conduct Report is completed.
- 5.4 The bus driver will give a copy of the report to the student and forward the remaining copies to the Transportation Department.
- 5.5 The Transportation Department will fax a copy of the report to the appropriate building's administrator and file copies in the Transportation Department.
- 5.6 The building administrator is responsible for determining the required discipline needed for the situation.
- 5.7 If the situation warrants suspension of transportation privileges, the building administrator must contact the Transportation Department and notify the parents of the terms of the suspension.
- 5.8 The Transportation Department will notify the driver of the details of the suspension of transportation privileges and the student will be allowed to resume privileges following this duration.


