

### Who is Homeless?

The federal government's legal definition of homelessness based on the McKinney-Vento Homeless Education Assistance Act is anyone who is...

- Lacking a regular, fixed and adequate nighttime residence
- "Doubled up" with family or friends because of loss of housing, economic hardship, or similar reason
- Living in a shelter, hotel or motel
- Living in a public place not designed for sleeping (cars, parks, abandoned buildings)
- A child who is not in the physical custody of their parent or legal guardian
- A child or youth abandoned in a hospital
- A migrant child who qualifies under any of the above

### Who is a Foster Youth?

- Foster youth are children placed away from their parent(s) or guardian(s) and for whom the State agency has placement and care responsibility.
- This includes, but is not limited to, placements in foster family homes, foster homes of relatives, group homes, emergency shelters, residential facilities, child care institutions, and pre-adoptive homes
- All children in foster care have a county caseworker. In Los Angeles County, the agency is the Department of Children and Family Services (DCFS). Other counties have different agency names, but provide the same services.

# **TUSD Program Goals**

- Support and meet the educational needs of students in homeless, temporary, transitional housing, or foster care situations
- Maintain consistency of the educational process
- Provide the same educational opportunities to students in homeless, temporary, transitional housing, or foster care situations as other students receive
- Engage parents, students, school, and community as full partners in the educational process of students in homeless, temporary, transitional housing, or foster care situations
- Provide a connection between school and home

School offers children stability, friendship, and opportunities to learn and grow in a safe environment. School also offers children a chance for better jobs, better pay, and a better future. Keep your children in school!



## **TUSD Program Services**

- Serve as a liaison between school, parents, students, and community agencies to meet the educational needs of students
- Connect students and families to district and community resources
- Provide enrollment information and support, with or without required documents
- Assistance for children to remain in their home school
