**Brief summary/key outcomes of the meeting:** Post-legislative forum activities: Mary Anderson is drafting a letter to Governor Rauner regarding the need to get the state budget passed as well as the need to improve/increase funding for education in Illinois. Theresa Jurgus is going to draft a letter to the editor or One View from CLAIM thanking legislators for coming to the November 2 forum and also provide some key take-aways from the event – once finalized, it will be sent to the Wednesday Journal.

Finance and Equity/Excellence work groups shared their respective “belief” sheets and proposed top legislative priorities.

**Next steps:** CLAIM will present its annual report at the December 1, 2015 board meeting. Rick Boultinghouse and Amy Felton are reviewing applications to appoint two new members to CLAIM with the resignation of Anne Warden and Brandon Bell.
