PRESIDENTIAL SCHOLARSHIP

Merit-based award covers 100% of tuition and fees

Requirements:

- 3.5 cumulative high school GPA
- Minimum 24 on ACT or Donnelly placement test equivalent
- Renewable up to 4 semesters with a 3.25 college GPA
- Limit of 5 new recipients per year

HENRY W. BLOCH SCHOLARSHIP

Merit-based award covers 100% of tuition and fees for up to six semesters at Donnelly College and then upon transfer to UMKC, 100% of tuition for up to six semesters.

Requirements:

- U.S. Citizen/Permanent Resident
- Must live in Kansas City metropolitan area
- Must be eligible for the Pell Grant
- Have not earned more than 30 credit hours
- High school diploma or GED
- Cumulative GPA of 2.5
- Must be pursuing an Associate of Arts degree from Donnelly
- Must provide transcripts, supplemental essay and two letters of recommendation

SISTER JEROME SCHOLARSHIP

Merit-based award covers 75% of tuition and fees

Requirements:

- 3.25 cumulative high school GPA
- Demonstrated financial need
- Renewable up to 4 semesters with a 3.25 college GPA
- Limit of 5 new recipients per year

BISHOP DONNELLY SCHOLARSHIP

Merit-based award covers 50% of tuition and fees

Requirements:

- 3.0 cumulative high school GPA
- Completion of FAFSA by March 1st
- Renewable up to 4 semesters with a 3.25 college GPA
- Limit of 5 new recipients per year

CATHOLIC HIGH SCHOOL AWARD

\$1,000 per semester

Requirements:

- Provide an official transcript from an accredited Catholic high school
- Maintain full-time enrollment status
- Renewable up to 8 semesters (excludes summer)

MIGRANT ASSISTANCE PROGRAM SCHOLARSHIP (MAP)

Merit-based award of 100% tuition and fees per semester, plus loaner laptop and \$1000 award year stipend. (\$500 per semester)

Requirements:

- US citizen or Permanent Resident.
- FAFSA/Pell Grant eligible.
- Preference is given to students who are identified as a current or former migrant student. (Definition: Student has, or has at least one immediate family member who has, spent a minimum of 75 days during the past 24 months as a migrant or seasonal farmworker; or is eligible to participate, or has participated, in a Migrant Education Program or the National Farmworkers Jobs Programs)
- Enroll as a full-time student with freshman status
- Renewable up to 2 semesters (excluding summer)

NATIONAL SCIENCE FOUNDATION STEM SCHOLARSHIP

Need-based renewable award of \$2,000/semester

Requirements:

- US citizen, nationals of the US, aliens admitted as refugees, or permanent residents
- Pursuing a Bachelor's degree in Information Systems or an Associate degrees with emphasis in Information Technology, Math or Natural Science
- Renewable each semester through graduation as long as you maintain a 3.0 GPA in STEM courses
- Must have at least a 3.0 GPA overall or a STEM GPA of at least 2.5 from high school or transfer institution
- Students receiving scholarship support must maintain full-time student status (minimum 12 credit hours per semester) and participate in all required Project S⁴ activities
- Demonstrated financial needs as defined for undergraduate students by the FAFSA

BIZFEST SCHOLARSHIP

Merit-based award of \$2,000 per semester

Requirements:

- 3.5 cumulative high school GPA
- Participation in BizFest (certificate required)
- Minimum 18 on ACT or Donnelly placement test equivalent
- Award is renewable with a 3.25 college GPA
- Limit of 4 new recipients per year

STUDENT SUPPORT SERVICES (TRIO) GRANT AID AWARD

Limited to current students only; based on availability,

Requirements:

- Pell Grant eligible (determined by FAFASA)
- First-generation college student and/or financial need
- GPA above 2.0 and in academic good standing

How to apply:

- Submit completed application to Mary Pflanz in room 211b
- Deadline: April 15 for fall semester; November 15 for spring semester

KC SCHOLARS

Whether you're a high school student or adult learner who is looking to continue your education, you may be eligible to apply for the Ewing Marion Kauffman Foundation's new KC Scholars program and attend Donnelly College.

KC Scholars is available to low and modest income students living in Cass, Clay, Jackson and Platte counties in Missouri, and Johnson and Wyandotte counties in Kansas.

Donnelly College will accept these two scholarships from the KC Scholars Program:

Traditional Scholarship

(Available for students starting Fall 2018 or later)

- Applications submitted by students in their 11th grade year
- Awarded up to \$10,000 per year, renewable up to five years
- Must maintain a 2.5 GPA or higher

Adult Learner

(Available for students starting Fall 2017 or later)

- Must be age 24 or older
- Awarded up to \$5,000 per year, renewable up to five years
- Deadline: April 15 for fall semester; November 11 for spring semester.
