

Current Student 2021-2022 SCHOOL YEAR REGISTRATION NOW OPEN!

Students currently registered at Lemont-Bromberек School District 113A must complete registration enrollment on an annual basis. This is also an opportunity for families to review student details in the system and provide updated contact information.

- Registration for current EC-7th grade students for the 2021-2022 school year will be completed online through the Skyward student management platform using the directions outlined below.
- Early Childhood/Learning Friends students will complete additional paperwork provided from Oakwood School as part of the registration process.
- Students that participate in the DHH program and do not reside within SD113A boundaries should register for the 2021-2022 school year with their home school district.

To streamline the proof of residency process, the district will automatically verify student address information using a residency database. Families whose residency we are unable to verify will be contacted and required to prove residency in person at the District Office. Proof of residency must be verified by May 1, 2021, in order to register your child for the 2021-2022 school year.

2021-2022 First through Eighth Grade Students:

- Log into your [Skyward](#) account using a computer.
- Do not log in using a mobile device.
- Click the 2021-2022 Student Registration tile that can be found on each student's dashboard.
- Verify or make additions/corrections to your student's information by **May 1, 2021**.
- Repeat and complete this process for each child.

- Once submitted, the registration tile on each student's page will be approved and removed.
- Registration will be marked complete upon payment of student fees after July 1, 2021.
