Message from the District

As we look forward to the 2020-21 school year, we are committed to providing quality academic learning experiences for children, while meeting social/emotional needs in a setting that is safe and engaging. We have created a framework for instruction, safety, operations, and other considerations. This framework was created based on collaboration with and/or information from the De Pere Health Department, Brown County Health Department, DPI models, the CDC, and many other individuals and organizations within our communities. We will continue our work to prepare positive experiences for students within an environment where they learn and succeed.

We are planning to bring students back to a traditional classroom learning model with enhanced safety and health protocols in place to reduce the risk of virus exposure. Based on the feedback we have received, we know that for some of our families and staff, the thought of returning to school creates fear and anxiety. For others, the thought of returning to a year of remote learning creates impossible questions about employment and the educational success of your child(ren).



Message from the District

Planning for reopening will continue to require a flexible approach. We know the information may change between now and September 1, or even after the school year has started.

As we continue to analyze details of how these frameworks are implemented, we want to thank those who have personally reached out to share their perspectives. This continues to be new ground for schools and we know that we are stronger and more effective for students and our community when we work together.

In the coming weeks and months, we remain committed to keeping you informed of any changes that may be required. Please continue to watch your email and our website for additional updates as we plan for students' return.

Current Plan to Open Schools Safely

(August 3, 2020)

- Grades 4K-12: All students will have the option to return to school five days per week (following the school calendar) beginning on September 1st with safety precautions and mitigation strategies in place.
- A remote learning option will be available for those who choose it.

Flexibility - We will be nimble in our ability to move among 3 scenarios based on evolving health data and guidelines.

(The plan could change prior to Sept. 1.)

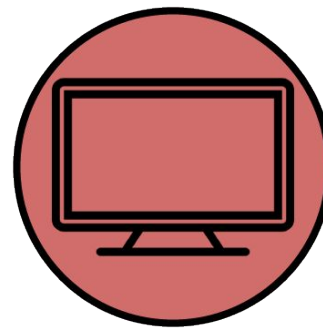

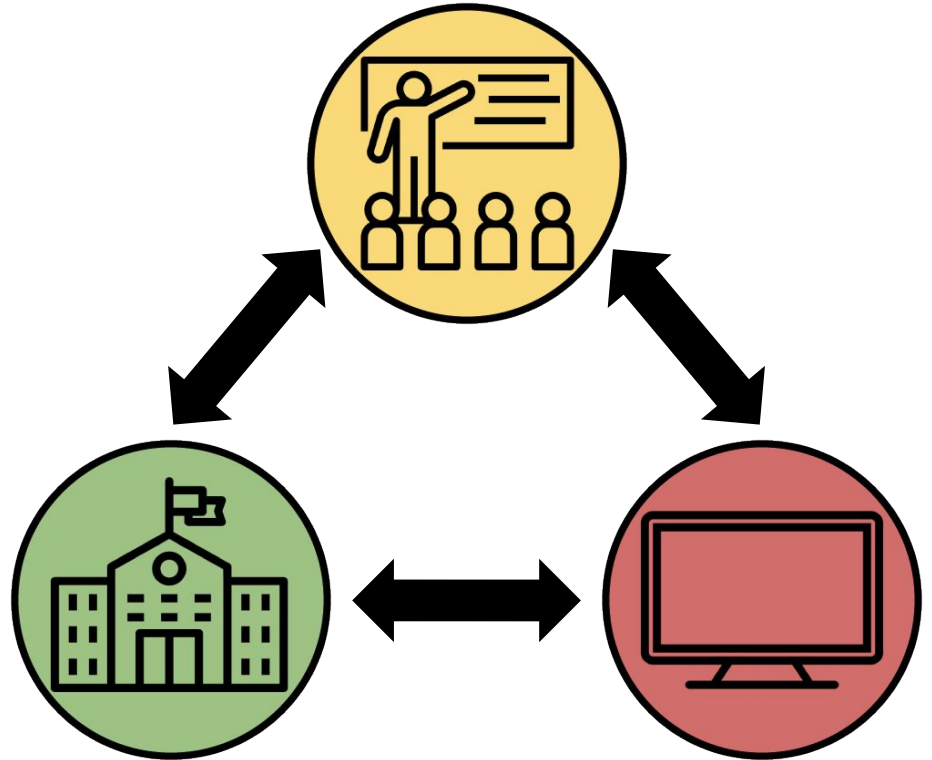

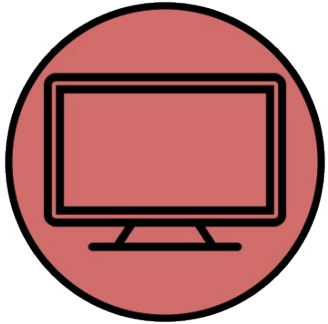

- The health needs of the school community may require short or long-term closures of classrooms, schools, and/or the district.

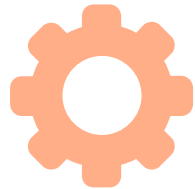


Mitigation Strategies

Risk Mitigation Strategies

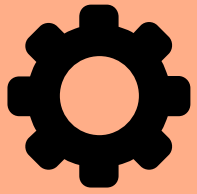
- **Physical Barriers**
 - Plexiglass barriers in offices
- **Floor Adhesives**
 - 6' separation markers in high traffic areas
- **Safety Signage**
 - Hand hygiene
 - Social distancing
 - Symptoms
- **Drinking Water**
 - Bottle filling only



School Physical Structure

Risk Mitigation Strategies

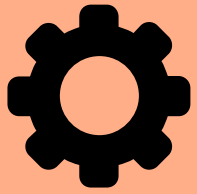
- **Sanitation Stations**
 - Placement in common areas and encouraged usage
- **Creating Space for Distancing**
 - Reconfiguration of teaching spaces and work spaces
- **Isolation Rooms for Students/Staff with COVID 19 Symptoms**
 - Identification of space and protocols for use
- **Cleaning and Disinfecting**
 - Increased daily and weekly protocols



School Operations

Risk Mitigation Strategies

- **Shared Objects**
 - Individual supplies or disinfecting between users
- **Hand Hygiene**
 - Teach and reinforce
- **Modify Building Layouts**
 - Adjusted pedestrian patterns
- **Visitors/Volunteers**
 - Limit non-essential visitors and visits
 - Drop off tables in each vestibule
 - No volunteers at this time



School Operations

Risk Mitigation Strategies

- **Cohorts**

- Elementary students stay within classroom and with same peers as much as possible

- **Entrances and exits**

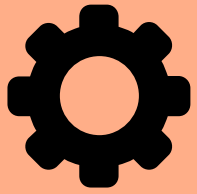
- Regulate access and directional flow

- **Field Trips**

- Will not take place at this time

- **Transportation**

- Masks required while on the bus
- Assigned seating with one child per seat with the exception of family members who will be seated together



School Operations

Risk Mitigation Strategies

- **Extracurricular Activities**
 - To be determined with input from WIAA and/or health department
- **Recess/Lunch**
 - Student interaction minimized via distancing, assigned seating, and/or staggered times
- **Meetings/Open House/Conferences**
 - Held virtually
- **Shared Snacks**
 - Individual, commercially-wrapped food
 - Distributed by teacher



Food Service

Risk Mitigation Strategies

- **Grab and Go Bags**
 - Breakfast and lunch
 - No self-serve options
- **Scanning ID badges**
 - In place of keypad for payment
- **Plexiglass barriers**
 - Between students and food service workers
- **Floor Adhesives**
 - 6' separation stickers in high traffic areas
- **Visitors**
 - Parents and other visitors may not join students for lunch



Student/Staff Physical Health

Risk Mitigation Strategies

- **Face coverings**

- Required for staff and students, 4K - 12
 - Mask breaks may occur when social distancing is possible and will occur while eating and during vigorous physical activity
 - Masks must cover nose and mouth
 - Masks reduce the risk of transmission in areas where distancing is difficult
- Visitors must wear face coverings

- **Health Aides**

- 1 per school building



Scenario A Information

At School

- In person attendance for all students in grades 4K - 12, 5 days per week, following the established school calendar.
- Risk mitigation procedures in place.
- Parents commit to one trimester at a time for the remote learning option.

Note: Remote learning will be an option for any student(s) whose family chooses it.

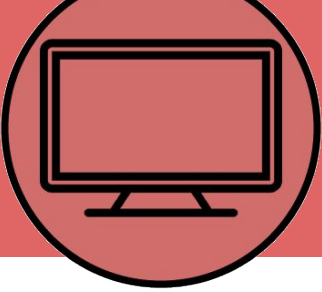


Scenario B Information

Blended

Universal guidelines 4K-12:

- Monday/Tuesday and Thursday/Friday cohorts for in person learning. Remote learning on the other three days.
 - Students divided by alphabet, with exceptions for families with multiple last names in the household (A-L on Monday/Tuesday; M-Z on Thursday/Friday)
- Wednesdays primarily utilized for cleaning and teacher planning.



Scenario C Information

Computer-based/Remote

Elementary: Asynchronous (not following a specified daily schedule)

Secondary: Synchronous (following a specified daily schedule)

- Instruction
 - Quality online instruction, consistency among staff, and regular student/teacher interactions
 - Standard grading
- Technology
 - Grades 5-12 will have school-issued Chromebooks.
 - Grades K-4 students who need a device will be provided with one.
- Pupil Service Staff
 - Modified working schedule so someone is available in evening for parents.
 - Mental health resources available for students/parents to access.
