US News and World Report: West De Pere HIgh School was once again recognized as an outstanding high school in the nation by U.S. News and World Report. Locally, West De Pere is recognized as the best in Brown County based on Advanced Placement participation rates.



Capital Projects: We have experienced a great deal of progress on our projects. It is exciting to see the plans becoming reality. I encourage you to view regularly undeted information regarding the projects on our web

Bonding Results: The final bonding results for the capital projects were very favorable and resulted in driving the pre-referendum mill rate impact projection from \$.55 to \$.31. Additionally, when our refinancing rate dropped from a projected 2.2% to .80%, it resulted in a projected savings of just over \$500,000 over the course of the next five years.

Strategic Planning: In 2021 we plan to evaluate our district vision, mission, and beliefs and define high level goals for future planning. Four-Year-Old Kindergarten Registration

The School District of West De Pere is now registering for our Four-Year-Old Kindergarten Program for children who will be four years of age on or before September 1, 2020, and are planning to attend Four-Year-Old Kindergarten in the fall of 2020. To register, please bring your child's birth certificate, their immunization record, and proof of residency such as a utility bill or lease agreement to either Westwood Elementary School or Hemlock Creek Elementary School.

If you have any questions concerning registration, please call Westwood Elementary at 337-1087 ext. 1322; Hemlock Creek Elementary at 425-1900 ext. 3320; or Scott Marsden, 4K Director at 337-1087 ext. 1323.

Our Four-Year-Old Kindergarten program is half days, five days a week. Depending on space availability at each site, children may be served at a location (either school or partnering child care facility) outside of their home school attendance area. If this occurs, transportation will be provided. Four-Year-Old Kindergarten is a voluntary program and no child will be required to attend. The Four-Year-Old Kindergarten program is developmentally appropriate and may include but is not limited to: readiness skills, language development, social development, emotional development, physical development, and self-help skills.

If you are not enrolled in our Four-Year-Old Kindergarten program, parents with children of kindergarten age (five years old) will be contacted via our school census report. If you are new to the area and have not completed a census form, please contact the District Office at 337-1393 ext. 8010 to have your child counted on the school census. If you know a neighbor with small children, please share this information with them.

Pre-School Developmental Screening

The School District of West De Pere offers developmental screening for preschool-aged children. The school district uses census data to mail out the Ages and Stages developmental questionnaires throughout the year, asking parents to complete the questionnaire and return it promptly by mail. As the questionnaires are returned, school professionals score them and provide written feedback to parents on the general developmental readiness of their child(ren). In certain circumstances, the school district will invite children to participate in an additional on-site screening. If you would like to request a developmental questionnaire, please call the Department of Student Services at (920) 337-1393 ext. 8012.

Five-Year-Old Kindergarten Registration

The School District of West De Pere recently held kindergarten registration for children who are planning to attend kindergarten in the fall of 2020. In case you missed it or did not attend our 4K program and you are planning on sending your child to kindergarten, please register your child as soon as possible at your school of residence: Hemlock Creek Elementary School, <u>1900</u> <u>Williams Grant Dr, De Pere</u> or Westwood Elementary School, <u>1155 Westwood St, De Pere</u>.

Children must turn five years of age on or before September 1, 2020 and live in the West De Pere School District to be eligible for the West De Pere kindergarten program. For registration, you will need to bring your child's birth certificate and proof of address. The child does not have to attend the registration. Grateful for our Food Service Workers



The West De Pere community would like to express how grateful we are for the Food Service workers in West De Pere. From March 18th until the end of June, they have prepared and distributed FREE Grab and Go breakfast and lunches in different locations around West De Pere. More than 85,000 meals were served to children ages 1-18.

Thanks to several generous donors, we received 60 gallons of milk, 600 pounds of fresh mozzarella cheese, 855 Seroogy's chocolate fudge eggs, 300 bags of coffee, 300 coloring books and crayons, dozens of handmade masks, 400 tote bags, 200 ice cream sandwiches, 200 frozen pizzas, 75 cases of Girl Scout cookies, 600 bottles of water, \$1,550 in monetary donations, as well as thank you cards from our students and families. I hope everyone has had a safe and healthy summer. If you would like to meet with me confidentiality to discuss your student's health concerns regarding the school year, please contact me by phone or e-mail. Just a few reminders to ensure the health and safety of all students:

<u>Please keep your student home if they are sick!</u> If your student becomes ill during the school day the following general guidelines will be used by school staff to determine if your student should be sent home:

- **COVID-19 or Influenza like Illness**-- symptoms such as ear temperature of 100.4 F or greater, along with respiratory symptoms of cough, shortness of breath, runny nose, sore throat, headache, body aches, chills, nausea and vomiting, diarrhea, new loss of taste or smell and fatigue.
- Fever of 100.4 F or greater
- · Vomiting and diarrhea
- Contagious illnesses such as chicken pox, strep throat, "pink eye" conjunctivitis, impetigo, scabies, live head lice or other determined by healthcare provider
- Rashes of unknown origin

Medication needs at school:

- *Prescription* medication must have a physician's order to dispense medication at school and is completed annually. The prescription drug must be supplied by the student's parent or guardian in the original pharmacy-labeled package, the package must specify the student's name, the prescriber's name, the name of the drug, the dose, the route, the effective date and the directions in a legible format.
- Over the counter/Nonprescription medication requires parent or guardian consent and is completed annually. The nonprescription drug product must be supplied by the student's parent or guardian in the manufacturer's package and the package must list the ingredients and recommended therapeutic dose in a legible format. A student may be administered a nonprescription drug product in a dosage other than the recommended therapeutic dose only if the request to do so is accompanied by the written approval of the student's healthcare provider.

• Medication forms are now available on the School Nurse district web page or the school office.

All medications will be dispensed by designated office personnel. Phone instructions or hand-written notes will not be accepted to dispense medication at school. The West De Pere School District will not supply medication.

Emergency Action Plan, Individual Health Plan or Health Alert; this plan communicates with school staff specific medical needs your student may have in the school setting. Health plans must be updated annually and are completed with the school nurse. Please contact the school nurse if you feel your student needs a health plan at school.

<u>Meningococcal disease</u> is a rare, but potentially deadly, bacterial infection that can take the form of meningitis. Teenagers and college students are at risk for this disease due to lifestyle factors. Meningococcal bacteria are transmitted through air droplets and/or by direct contact with secretions from infected persons. Meningococcal disease is often misdiagnosed since symptoms are similar to those of common viral illnesses. Symptoms may include a high fever, severe headache, stiff neck, nausea, vomiting, sensitivity to light, confusion, exhaustion and/or a rash. The Center for Disease Control and Prevention (CDC) recommend routine vaccine immunization for 11-12 years old with a booster at age 16. Teens and young adults (16 through 23-year olds) also may be vaccinated. Information is available on the School Nurse Web page, your healthcare provider or your local public health department.

Together, we can keep our students healthy and in school. Thank you!

Wisconsin Immunization Law

Any student admitted to any elementary, middle, junior, or senior high school shall, within 30 school days after the date on which the student is admitted, present written evidence to the school of having completed the first immunization for each vaccine required for the student's grade and being on schedule for the remainder of the basic and recall (booster) immunization series for mumps, measles, rubella (German measles), diphtheria, pertussis (whooping cough), poliomyelitis, tetanus, and other diseases that the department specifies by rule or shall present a written waiver. The immunization requirement is waived the student (if an adult) or the student's parent, guardian, or legal custodian submits a written statement to the school objecting to the immunization for reasons of health, religion, or personal conviction. The student, (if an adult), or the student's parent, guardian, or legal custodian shall keep the school informed of the student's compliance with the immunization schedule.

BUSSING AND TRANSPORTATION

Policy #3541

Students who are residents within the School District of West De Pere attendance boundaries are entitled to transportation provided by the school district if the following conditions apply:

- All students living two miles or more from the school they are required to attend will be transported.
- Students living less than two miles from the school they are required to attend will be transported if they are subjected to an "unusual hazard" area while walking to school. All students between 4K and 6th grade will be considered for bussing if they live in an area considered an "unusual hazard". Such "unusual hazard" must be consistent with School Board Policy 3541(R). These hazardous areas will be re-evaluated every five (5) years. Affected families will be advised in writing of any bussing change that is a result of this re-evaluation.
- Parents of students not eligible for district funded transportation may contract for such directly with the bus contractor.
- Beginning the 2017-2018 school year, all resident 4K students will be offered transportation to and from the school they attend.

Disabled Students

- (a) Pursuant to Wisconsin Statutes. transportation shall be provided to those students who reside within the school district and the students' IEP determines transportation to be a related service.
- (b) Disabled students will be transported on the regular buses if they are able to get on and off the bus with little or no assistance and do not require any special care while on the bus.
- (c) The district will provide the necessary transportation for disabled students who cannot ride the regular school bus.
- (d) Every occupant shall be secured to the wheelchair while being transported. The securement shall be separate and in addition to securing the wheelchair to the bus. Belts securing the occupant to the wheelchair shall be the responsibility of the owner of the wheelchair, parent or guardian.

TOBACCO/NICOTINE USE ON SCHOOL PREMISES Policy #1335

Tobacco and nicotine use are prohibited at all times on school premises. "School premises" include all property owned by, rented by or under the control of the School District of West De Pere.

Possession of tobacco or nicotine products by minors is prohibited.

The administrative staff shall inform students, staff and the general public about this policy and shall establish enforcement procedures.

For purposes of this policy, "Tobacco and nicotine use" means to chew or maintain any substance containing tobacco, including smokeless tobacco, in the mouth to derive the effects of tobacco, as well as all uses of tobacco, including cigars, cigarettes, pipe tobacco, chewing tobacco, snuff, any other matter or substances that contain tobacco or nicotine, in addition to papers used to roll cigarettes and/or the smoking of electronic, "vapor," or other substitute forms of cigarettes, clove cigarettes and any other lighted smoking devices for burning tobacco, nicotine, or any other substance.

DISTRICT RESIDENT REQUEST FOR SCHOOL TRANSFER Policy #5007

District residents who request to transfer schools within the School District of West De Pere for the 2020-2021 school year are due **January 31, 2020**. Guidelines to the West De Pere policy #5007 are:

- 1. Only written requests will be considered.
- 2. Requests by district residents for school transfer shall be made in writing during the month of January. Requests received after January 31st may be considered if space is available. Applicants should submit their written request by completing the "District Resident Request for School Transfer" form. Written requests should be submitted to the school office. Final decisions will be made by the building principals. Parents/ guardians have the right to appeal decisions to the district office.

ELECTRONIC COMMUNICATION DEVICES

Policy 5130 (Reference: 1989 Wisconsin Act 120, Wisc. Stats.118.258)

It is the policy of the School District of West De Pere that students who possess an electronic communication device during the school day will be required to keep the device off should the administration have determined that the device has become a disruption in the school setting.

Electronic recording devices are prohibited from use and display while in district facilities or while in attendance at district sponsored activities in places where others have a reasonable expectation of privacy to include, but not limited to, locker rooms, shower rooms, restrooms.

If a device is confiscated for disruptive use, it will be held by school officials for return to parent(s)/guardian(s) of the student, retained for disciplinary reasons, or turned over to law enforcement officers. Students will be disciplined in accordance with procedures specified in relevant District policies, school handbooks, and State and Federal Statutes.

Use or possession of an electronic device is allowed if the school board or its designee determines that the device is used or possessed for medical, school, educational, vocational, or other legitimate use.

Students violating this policy may be subject to suspension, expulsion, or other penalties. Students shall be informed of this policy through publication in the student handbook.
