## **Residency Alert**

Many suburban school districts, including District 73½, have been burdened with non-resident students enrolled in their schools. This is not fair to the taxpayers!

Our Board of Education has taken a firm stand on identifying and removing out-of - district children who are illegally enrolled in our schools. If you believe that someone is attending one of our schools who is not a resident of our district, we ask that you alert us to this situation as soon as possible. All information given to us is confidential and your anonymity is ensured.

If we suspect illegal enrollment, we will take the following actions:

- Review the student's information we have on file
- Hire surveillance teams to check residency
- Hire private investigators to gather evidence

If our evidence indicates illegal enrollment, the Board will exercise its right to collect owed tuition, current and retroactive. The tuition rate for the 2018-19 school year is approximately \$15,039.21. The actual rate will be determined in October 2018 and made retroactive to the first day of school.

Residency is defined as that place where parents/legal guardians eat, sleep, and store their belongings; furthermore, it is that place in which their child resides with them for four or more days per week. A student's residence is the same as the person who has legal custody of the student. Refer to Board Policy 7.60.

To be a legal resident of Skokie School District 731/2, a child must ...

- Reside within the school district with his/her natural parents or
- Reside within the school district with his/her <u>custodial parent</u> if parents are divorced or
- Reside within the school district with a person to whom custody and control have been legally transferred by the courts. The intent of such transfer cannot have been solely to enable the student to attend school in this district.

If you are the parent/ guardian of a child illegally enrolled in this district, you are advised to withdraw your child immediately.

#### **WARNING:**

If a student is determined to be a nonresident of the District for whom tuition must be charged, the persons enrolling the student are liable for non-resident tuition from the date the student began attending a District school as a non-resident.

A person who knowingly enrolls or attempts to enroll in this School District on a tuition-free basis, a student known by that person to be a nonresident of the district, is guilty of a Class C misdemeanor, except in very limited situations as defined in State law (105 ILCS 5/10-20.12b(e).

A person who knowingly or willfully presents to the School District any false information regarding the residency of a student for the purpose of enabling that student to attend any school in that district without the payment of a nonresident tuition charge is guilty of a Class C misdemeanor (105 ILCS 5/10-20.12b(f).
