## Bank Verification Form of Financial Solvency INTERNATIONAL STUDENTS (F-1 VISA)

**Dear Parents/Legal Guardians:** It's a requirement of St. Catherine's Academy (SCA) that students applying for an F-1 Student Visa present evidence of financial solvency prior to acceptance at SCA and the issuing of the I-20. Because the applicant is a minor, the allocation of a *guarantor* is required. The *guarantor* is usually the applicant's parents. The *guarantor* must demonstrate that he/she has sufficient financial capacity to cover the cost of tuition, room and board and additional fees during the 2021-2022 school year at SCA. The *guarantor* should be the same person who signs the enrollment contract.
