One of the men called out: "Sister Dorothy!" She turned and saw a revolver in his hand. She reached into her bag.

He taunted her. "Are you reaching for your weapon?"

Rayfran looked at his partner, then back at her.

Rayfran couldn't bear to hear any more. He readied the gun with a click. Dorothy raised her hand as if to ward off a blow.

The first bullet hit her in the hand. She fell, face forward holding her Bible.

Rayfran stood over her and, in cold blood, fired five more shots into her back and head. Cicero ran for help.

Because it was the rainy season and the roads were nearly impassable, and because of the lack of telephones in Esperanca, eight hours passed before the police arrived. It is said that Dorothy's body never stiffened 3ut was kept soft by the gentle, heavenly rain.

Blessed are you when they insult you and persecute you and utter every kind of slander against you because of me. Be glad and rejoice, for your reward is great in heaven. Dorothy Stang became a martyr.

When great trees fall in forests, small things recoil into silence, their senses are eroded beyond fear... Lions hunker down in tall grasses, and even elephants lumber after safety.

- 4. Two groups claim to have rights to the land in Pará and specifically to Lot 55. What are the two groups? Which is more powerful? Which side is Sr. Dorothy on?
- 5. After Sr. Dorothy is murdered, the president of Brazil sends the military in to keep the peace and also declares a "moratorium on all new logging permits." What does that mean?

- 6. Who is Sr. Jane Dwyer SNDdeN? What does she believe about who was behind Sr. Dorothy's death?
- Who is Clodoaldo Carlos Batista or "Tato"? What new information does he provide about Sr. Dorothy's murder?
- 8. Who is Vitalmiro Bastos de Moura or "Bida"?
- Make a prediction: Will "Bida" serve time for Sr. Dorothy's murder? Explain your prediction.

5. How many people have been murdered as a result of land disputes in Para? How many people have been brought to justice as a result of those murders? What do these numbers say about the justice system in Para?

6. Why do David Stang and Dorothy's religious community in Brazil want her case to be tried by the federal government rather than the state government?

7. Do they win the right to have Sr. Dorothy's case tried at the federal level?

8. Sr. Jane Dwyer hopes that the state prosecutors can send Rayfran Sales and his accomplices to jail for murdering Sr. Dorothy, but particularly for being *ordered* to murder Dorothy. Why is it so important to Sr. Jane that the fact that they were *ordered* to carry out Sr. Dorothy's murder comes out in the trial?

9. Americo Leal has agreed to defend the accused gunmen--Rayfran das Neves Sales, Clodoaldo Carlos Batista and "Tato"--besides his own clients the ranchers, "Bida" and Regivaldo Pereira Galvao, "Taradao". Is this good news for Sr. Dorothy's family, friends and supporters? Why do you think he is offering to represent Rayfran and Tato for free?

10. What is Americo Leal's version of why Rayfran killed Sr. Dorothy? Do you agree with his version of events?

11. Americo Leal's associate makes a phone call (he's sitting in the back seat of the car) to Rayfran's mother. She is very angry with him. Why?

12. Clodoaldo, Rayfran's accomplice, decides to drop Amerco Leal's team as his defense lawyers and go with a public defender. Why? Did he make a wise decision?

13. How much money was paid to Rayfran and his accomplices for killing Sr. Dorothy?

14. What was your reaction to hearing this detail of Sr. Dorothy's murder? Did it raise any questions? Thoughts?

15. Why do Sr. Becky Spires and David Stang say they *hope* the verdict in this trial means a "new beginning" in Para? What still has to happen to show that things really are changing for the better there—for the land and the people?
