Expectations for B&A students and families:

1. Same rules & behavior expectation as during school
2. Students need to be in assigned areas on time
3. Students may not be dropped off before 6:30am
4. Students must be picked up before 6:00pm
5. Drop-off and pick-up will use entrance #1
6. Pack healthy snack for your child each day
7. Inappropriate behavior of child, late payments or late pickups may lead to dismissal from program
8. On days of inclement weather or emergencies: If school is closed early we ask that you pick up your children as soon as safely possible. We will try to be open as usual on Late- In mornings, but the parking lots may not be plowed. Never leave your child without signing them into the room. If school is closed for the day there is no B&A
